

Customer Service Guarantee Exemption Advice – 20241029-QLD-E-C-I-SOUTHEAST COAST DISTRICTS

Parts of the Beaudesert, Brisbane West, Burleigh, Caboolture and Sunshine Coast Districts for Queensland were impacted by severe thunderstorms resulting in heavy rainfall exceeding the 10 Year average, hailstones with diameter greater than 2 centimetres, flash flooding and cloud to ground lightning strikes between 29th October 2024 to 30th October 2024.

An interruption to Telstra’s normal operations has occurred leading to delays in installation and repair activities. We estimate that as many as 382 Telstra services may be impacted.

How will this affect you?

We anticipate that most services will be restored by 20th November 2024. We're sorry for any inconvenience this delay may cause but we can assure you we are working hard to get things back on track.

In the event this timeframe is extended, a revised notification will be provided.

What else do you need to know?

Due to the extreme weather conditions, we're claiming an exemption under section 24 of the Telecommunications (Customer Service Guarantee) Standard 2023, including an exemption from the payment of compensation between 29th October 2024 to 20th November 2024 inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.
