## **Customer Service Guarantee Exemption Advice – 20250124-QLD-E-C-I-SOUTH EAST AND WEST DISTRICTS**

Parts of the Beaudesert, Brisbane Island, Brisbane North, Brisbane Southeast, Brisbane West, Burleigh, Caboolture and South West Districts for Queensland were impacted by severe thunderstorms resulting in cloud to ground lightning strikes and hazardous winds between 24<sup>th</sup> January 2025 to 25<sup>th</sup> January 2025.

An interruption to Telstra's normal operations has occurred leading to delays in installation and repair activities. We estimate that as many as 441 Telstra services may be impacted.

## How will this affect you?

We anticipate that most services will be restored by 28<sup>th</sup> February 2025. We're sorry for any inconvenience this delay may cause but we can assure you we are working hard to get things back on track.

In the event this timeframe is extended, a revised notification will be provided.

## What else do you need to know?

Due to the extreme weather conditions, we're claiming an exemption under section 24 of the Telecommunications (Customer Service Guarantee) Standard 2023, including an exemption from the payment of compensation between 24<sup>th</sup> January 2025 to 28<sup>th</sup> February 2025 inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.

The exemption process is explained in sections 24–30 of the *Telecommunications (Customer Service Guarantee) Standard 2023*, which can be found on the **Australian Government**, **Federal Register of Legislation** website.
